WALK-THRUS AND RUNNING ORDER

Preliminary running order contingent on move-up entries not yet received. Judging starts at 8:00am, please arrive early. Briefing and walk-thrus will occur no earlier than 7:30am. Breaks and split walk-thrus are at the judge's discretion.

Running order will be small to tall (4"-26") on Saturday and tall to small (26"-4") on Sunday. All classes will be run concurrently (B's, A's, then Preferred) within each height class. Please note that the running order is not necessarily run sequentially by armband numbers. Handlers with multiple dogs have been moved to try to minimize conflicts.

Electronic timers WILL be used. Please make sure you check in with the gate steward and are at the gate at least 4 dogs ahead of your turn.

DIRECTIONS

From the North via Rt 113S

Take Rt 113S /Rt 1S to Frederica. Turn right onto Rt 12. Follow Rt 12 through Frederica. Rt 12 will turn right in Frederica onto E Front St. Follow Rt 12 approximately 2.7 miles. Turn right onto Robbins. The site is on the right.

From the South via Rt 113N

Take Rt 113N to Frederica. Turn left onto Frederica Rd. Turn right to remain on Frederica Rd. Turn left on E Front St (Rt 12W) and follow for 2.7 miles. Turn right on Robbins Rd. The site is on the right.

From the South via Rt 13N

Take Rt 13N to Felton. Turn right turn onto Midstate Rd (Rt 12). Go approximately 3 miles. Turn left onto Robbins. The site is on the right.

From the West (Bay Bridge)

Take Rt 50/301 East. Merge on to US 50 East. Turn left onto 404. Go North on MD 313. Turn right onto MD 317. MD 317 changes to DE 14 in Delaware. Follow DE 14 through Harrington to Rt 13. Turn left onto Rt 13. Follow direction from the South via Rt 13N.

NORTH. Continue To Follow SOUTH DUPONT HIGHWAY NORTH/US-13 NORTH

Turn RIGHT Onto WEST LEBANON ROAD/DE-10 EAST

END At 1482 East Lebanon Road, Dover, DE 19901
